- The price is for a minimum of 60 adult guests (age 12 and above) to a maximum of 100 adults
- The period of offer for this package is from 2nd January 2022 to 28th February 2022 inclusive and is non transferable (Covid Restrictions excluded)
- A booking fee of \$1,000.00 must be paid to secure your date along with a signed booking form to acknowledge the terms and conditions associated with this package
- Payment of your booking fee and signatures are taken as an understanding of all terms and conditions of business contained in the document and that you are happy to proceed with holding your wedding and reception at Weddings In The Grove
- Weddings In The Grove reserves the right to refuse a booking in circumstances whereby a booking is made under a false pretence or by a third party. Refusal is at the discretion of Weddings In The Grove
- The price per head is inclusive of GST
- A security deposit of \$500 must be paid at time of final invoice to cover any damages to the property, fixtures and fittings or any item used during the reception or wedding ceremony. If no damages are found after the event, then the security deposit will either be paid back in full or the balance paid less any deduction for damages caused
- Final numbers for meals are required 30 days in advance of the wedding date
- Should your final guest numbers drop below 60 adult guests, then in all cases the minimum price for 60 adults will still apply for this package, irrespective of the final numbers below this package number
- An invoice for the balance of the account will be sent to you 21 days prior to the event date. The final balance of the account must be settled 14 days prior to the event date
- The venue hours are 8:00am to 10:30pm Monday to Thursday & Sunday and 8:00 am to 12:00am Friday & Saturday.
- Last drinks will be called 30 minutes prior to the nominated closing time
- All music must finish at the nominated closing time
- Weddings In The Grove can not be held responsible for third party suppliers whose services are supplied as part of this package, as Weddings In The Grove engages these suppliers in good faith
- Weddings In The Grove is not responsible for any extras or incidentals that you agree with the package suppliers over and beyond what is included as standard in this package
- The booking fee once paid is non refundable and non transferable and will be forfeited to Weddings In The Grove should you cancel your booking
- Due to the specific time period for this package a change of date outside of the nominated period will incur additional costs
- In The Grove practices Responsible Service of Alcohol, under no circumstances are underage guests permitted to consume alcohol. The supply of measured spirits must be served by an RSA licensed operator. This will incur an additional cost if you choose to bring measured spirits to your event
- Package price excludes Alcohol, Soft Drinks and Entertainment
- Every endeavour will be made to maintain the price as quoted, however it is subject to change. Should any increases occur, we will notify you immediately
